Garneau Tennis and Beach Volleyball Club – RELEASE AND WAIVER FORM

For the purpose of this Release and Waiver Form, a Recreational Activity is defined as the Sport of Tennis and/or the Sport of Beach Volleyball. I recognize that Recreational Activity involves risks, which could cause me serious bodily injury including death or property loss. The risks include, but are not limited to: actions or negligence on the part of Releasees (as defined below), including the failure on the part of the Releasees to safeguard or protect me from risks, dangers and hazards of the Recreational Activity, the Facility (defined below) or COVID-19; suitability or general conditions of the Facility to engage in Recreational Activity, including defective or dangerous equipment, club property, the premises or any public facilities (collectively, the “Facility”); the transmission of COVID-19, including as a result of a breach of or failure to implement health guidelines or policies related to COVID-19; actions or negligence of other people including, but not limited to, other members and non-members, staff, volunteers, spectators, event officials, event monitors and/or organizers or sponsors; failing to play safely or within the limitations of one’s own abilities; lack of hydration; weather; COVID-19; and/or other conditions. In consideration of Garneau Tennis & Beach Volleyball Club accepting my membership, I hereby for myself, my heirs, executors, administrators and assigns, forever release and forever discharge Garneau Tennis & Beach Volleyball Club, their executive directors, servants, agents, sponsors, supporters, employees and volunteers (the “Releasees”) from any and all claims, demands, damages, costs (including solicitor and client costs on a full indemnity basis), actions or causes of actions, proceedings arising out of or in consequence of any loss, injury including death or damage which may arise during or outside any Recreational Activity or in connection with my use of the Facility whether or not caused or contributed to by the actions, omissions or negligence of the Releasees or any of the risks identified herein.

I declare that my physical condition, to the best of my knowledge, is adequate to participate safely in Recreational Activity and that no physician or other qualified individual has advised me against participating in Recreational Activity. I also declare that I have read, understood, and agree to abide by the Rules and Regulations as set forth by the Garneau Tennis & Beach Volleyball Club from time to time including the policy pertaining to play as a result of COVID-19 measures. I further acknowledge and agree that it is my choice as to whether I will obtain a physical examination prior to participating in Recreational Activity, and I hereby acknowledge and agree to assume all risks associated with not obtaining such examination. Or if I do obtain an examination and am instructed not to participate in Recreational Activity, I hereby assume all risks associated with my participation.

I authorize and consent to the publication by the Garneau Tennis & Beach Volleyball Club of any materials containing my name and/or picture, and I release to the Garneau Tennis & Beach Volleyball Club and all persons acting under authority from them any claims I might have due to the initial or subsequent publication of such material.
